### Remarks

- The PPEG database comprises all political parties that have secured at least one seat in the national lower chamber. This means that a party’s election results are retrospectively included. For example, if a party secures a seat for the first time in the fifth election it has contested since its founding, we add the party’s vote share for all five elections. These updates are not listed in this document.
